# INTRODUCTION



The Idaho State Law Library was established in 1869 under an Idaho territorial statute that included a \$500 appropriation for the purchase of law books. Currently located at 501 W. Front St., the Law Library operates under the joint management of the Idaho Supreme Court and the University of Idaho College of Law. As a result of this collaboration, library patrons have access to a greatly enhanced collection of print and electronic research tools. The print collection consists of 30,000 volumes. Two public computer terminals provide access to a variety of research databases, including Westlaw. We are continually updating our collection to provide more and better access to legal information.

## USE OF LIBRARY RESOURCES

The Law Library is open to the public. Although primarily a research library, limited lending is available for Idaho judges and attorneys, members of the Idaho State Bar, and University of Idaho law students and faculty.

## LIBRARY COLLECTION
