If you fail to respond the Court may enter an order to enforce parenting time against you as demanded by the requesting party in the Petition to Enforce Parenting Time.

If the Court grants the Petition to Enforce Parenting Time, it may order you to pay costs of this proceeding. If you wish to seek the advice of or representation by an attorney in this matter, you should do so promptly so that your written response may be filed in time and allow adequate time to prepare for the hearing.

This Summons and the Petition to Enforce Parenting Time must be served upon the responding party not less than 14 days [computed using Rule of 104 of the Idaho Rules of Family Law Procedure] prior to the date of the hearing.
